CARES Act Funding at Brown University

Brown University has applied for funding under the Coronavirus Aid, Relief, and Economic Security (CARES) Act signed into law on March 27, 2020. Brown University has received an award notice of funds obligated to the institution. While the Department of Education has awarded and obligated these funds to Brown University under the CARES Act, the University has not yet made a final decision about these funds.

The University is dedicated to ensuring that any fund distribution would fulfill the intent of the CARES Act. Brown would be committed to ensuring that 100% of the dollars would provide the intended support for students related to the disruption of campus operations due to novel coronavirus.

As part of the application process for CARES Act funding, Brown University is obligated to create, maintain, and update public reporting on the use of these funds. This web page fulfills these obligations to the Department of Education.

Brown University is assigned OPE ID number 00340100 by the federal government, and the award notice for the obligation of funds under the CARES act from the federal Department of Education to Brown University is assigned the tracking number GAN P425E202729.

While Brown University has not made a decision about the funds, the University acknowledges that it signed and returned to the Department the Certification and Agreement and made the assurance that the institution has used, or intends to use, no less than 50% of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.

Brown University has received and may use up to \$2,421,116 from the Department of Education pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students. Brown University has distributed \$0 of Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act as of the date of this report.

For the estimated number of Brown University students who are eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus may be eligible to receive Emergency Financial Aid Grants under Section 18004(a)(1) of the CARES Act, please see the table below for each reporting period.

Because Brown University has not yet finalized a program to implement and use these funds, the total number of students who have received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act is zero (0).

The methods to be used by Brown University to determine which students receive Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act along with any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants have yet to be determined.
